### About the service

Mr & Mrs Aubeeluck provide a housing support service to one person (referred to as the service user within the report) whom they have known for over 20 years. The service user has a learning disability and lives in his own tenancy near to the service provider. The service is provided for 13 hours a week anytime during a 24 hour period.

The service aims to:-

- Provide a high quality of support and care
- Assist the individual to maintain his independence and his tenancy through a varied programme of activities
- Respect the individual's rights
- Give as much privacy as possible, especially within the community
- Encourage independence in the areas of cooking, cleaning and personal hygiene
- To offer support in claiming all appropriate welfare benefits, social services and health services.

The service was registered with the Care Commission in September 2004 to provide a Housing Support Service.

### What people told us

The person who uses the service told us he was very happy with it and did not want to make any changes.

### What the service does well

Mr & Mrs Aubeeluck provided very good personalised support to the person using the service. He told us that he worked with Mr & Mrs Aubeeluck on an ongoing basis to develop his household skills such as cooking, cleaning and budgeting. This allowed him to live independently in the community. He was also playing an active part in the local community through his work at a charity shop.

The person using the service told us that he met with Mr & Mrs Aubeeluck most days and he could speak to them at any time about his support. He told us that he was fully involved in putting together his support plan. If he wanted to change his support plan, Mr & Mrs Aubeeluck listened and supported him to make those changes. Reviews of the support plan were now taking place on a six monthly basis.

The service was committed to supporting the person's human rights through their practice and policies. Mr & Mrs Aubeeluck had a great deal of experience in supporting people and were aware of their rights. This was reflected in their documentation and policies. They had also updated the Adult Support and Protection policy.

### What the service could do better

Mr & Mrs Aubeeluck should continue to have discussions with the person being supported on how he wants the support to develop. This should include his personal outcomes from the support and how he can develop his own skills further.
