Inspection report

About the service

This service registered with the Care Inspectorate on 1 April 2011.

Lothian Supported Carers Scheme is an adult placement service and is registered to provide an adult placement service to young people over the age of 16 years within individual family homes, with a focus on young people who have previously lived in the care system and require support to more independent living. The service is a consortium project between Barnardo's Scotland and the City of Edinburgh Council, West Lothian Council, East Lothian Council and Midlothian Council and is directly funded by Barnardo's Scotland.

At the time of the inspection, the service had one active carer and no young people in placement.

The aims and objectives of the service are:

"To provide quality supported carer placements for vulnerable young care leavers in order to improve their transition from being "looked after" to living within the community, allow a secure and supportive home environment and assist them in developing the practical skills and emotional resilience to live more independently".

What people told us

We tried to contact the one active carer during the inspection, however we were unsuccessful in that contact.

We sent out Care Standard Questionnaires, however as there were no young people in placement we did not receive any completed questionnaires.

Self assessment

The service had not been asked to complete a self assessment in advance of the inspection. We discussed their own improvement plans and quality assurance systems which identified their priorities for development and how they were monitoring of the quality of the provision within the service.

From this inspection we graded this service as:

Quality of care and support4 - GoodQuality of staffingnot assessedQuality of management and leadership5 - Very Good

What the service does well

The support worker had a thorough knowledge and understanding of his role and that of the carer. He had provided consistency to the service in delivering support to carers over time and was very committed to the service.

Established systems were in place to carry out assessments and vetting of carers to ensure they were suitable and understood what was expected of them.

Risk assessment processes supported carers to identify strategies to be used to feel confident in managing and mitigating risk. The identified strategies helped carers to support young people to make safe choices.

Support plans evidenced high quality relationships between the support worker and the carer and highlighted ways in which the support worker had kept the carer engaged with working with the young people.

Lothian Supported Carers Service was part of a wider through care and after care resource as part of a national group including targeting homelessness and unaccompanied minors. This ensured that they were up to date with current best practice and guidance.

The continued positive relationship with placing authorities ensured that the service was available for referral of young people.

The service operated an adolescent carers group and had plans to resurrect a carers' forum in the future in order to provide peer support for carers and an opportunity to attend training.

The service action plan identified strategies to progress the service including recruitment of a previous carer on the panel to provide a service user view.

The service worked very well with other agencies to further support carers and young people.

The enthusiastic management team had a vision for raising the profile and expanding the service.

Robust management systems were used to monitor quality within the service, for example fit person checks for carers and professional registration of staff. Staff received regular supervision from their line manager and worked within service guidelines and procedures to support carers and young people. Joint visits and individual visits to carers ensured that managers had direct contact with carers to get their views and provide a point of contact.

What the service could do better

At the time of the inspection the service did not have an active panel to review current carers or sanction prospective carers' applications. If the service is to move forward it is important that establishment of the assessment panel takes priority.

Having cut the out of hours service, the service needs to identify where carers can access out of hours support.

There had been significant changes to the management of the service and a reduction in the recruitment and retainment of carers. The new management team now need to carry forward the plan of action to provide stability to the service and make decisions about how the service can expand and flourish. (see Recommendation 1)
