About the service we inspected

Craigton Lodge Nursery was previously registered and transferred its registration to the Care Inspectorate on 1 April 2011. It is registered as a day care of children to provide a care service to a maximum of 70 children aged between 0 and 5 years. Craigton Lodge Nursery operates Monday - Friday between the hours 8.00am - 6.00pm. The service will comply with the following staffing:

Age of Children Ratio - Adults to children

0 - 2 years 1:3

2 - 3 years 1:5

3 and over 1:8.

Two adults must be on duty at any one time (only adults in contact with children for the majority of the session should count towards ratios).

The service operates from two separate units set within their own grounds in the village of Peterculter, to the West of Aberdeen. The schoolhouse provides a care service for children aged from birth to 3 years. The other building known as Craigton Lodge Nursery provides a care service to children over the age of three. There is a large, fully enclosed garden for outdoor play.

The aims of the service include being committed to, "work in partnership with parents, respecting their knowledge of their child, and to provide support to families."

We check services are meeting the principles of Getting it right for every child (also known as GIRFEC). This is Scotland's national approach to improving outcomes and wellbeing for children by offering the right help at the right time from the right people. It supports them and their parent(s) to work with the services that can help them. There are eight wellbeing indicators at the heart of GIRFEC. They are: safe, healthy, achieving, nurtured, active, respected, responsible and included. They are often referred to as the SHANARRI wellbeing indicators.

How we inspected the service

A shared Education Scotland and Care Inspectorate inspection took place during the week beginning 10 December 2018. As a result of this inspection the Care Inspectorate made two requirements and six recommendations. Following the inspection in December 2018, the provider submitted an action plan and quality assurance calendar on the 20 March 2019 advising how they planned to meet the requirements and recommendations made during the inspection.

We visited the service on 26 March 2019 to complete a planned improvement visit and to assess if the provider had met the requirement that was due to be actioned by 14 January 2019.

During our visit in March 2019, we discussed the progress the service had made and gave advice as to how they could further improve the outcomes for children.

The outstanding requirement and the recommendations will be assessed during the next full inspection of the service.

Taking the views of people using the service into account

The children appeared happy and settled in the nursery.

Taking carers' views into account

We spoke to the manager and staff as part of the improvement visit. We did not speak to any parents during the visit and parents will be contacted for their opinions, views and suggestions when a full inspection is completed.

What the service has done to meet any requirements we made at or since the last inspection

Previous requirements

Requirement 1

To ensure children are protected from harm and neglect and that their wellbeing needs are met, the provider must ensure:

- the manager and staff are alert and respond appropriately to signs that children may be at risk of harm or their wellbeing may be compromised
- communication is effective including the sharing of records between the manager and staff.

Timescale - By 14 January 2019.

This is in order to ensure that care and support is consistent with the Health and Social Care Standards which state that 'I am protected from harm, neglect, abuse, bullying and exploitation by people who have a clear understanding of their responsibilities.' (HSCS 3.20); and 'I am protected from harm because people are alert and respond to signs of significant deterioration in my health and wellbeing that I may be unhappy or may be at risk of harm.' (HSCS 3.21); and in order to comply with Regulation 4 (1) (a) (Welfare of Users) of the Social Care and Social Work Improvement Scotland (Requirements for Care Services) Regulations 2011.

This requirement was made on 27 February 2019.

Action taken on previous requirement

Staff were well informed of their roles and responsibilities in protecting children. The service had implemented the Aberdeen City Child Protection policy to ensure staff were fully aware of best practice procedures to safeguard children. A clear flowchart with the procedures to follow in the event of a concern was clearly displayed on the staff notice board and in the office. All staff were informed of their responsibilities and their knowledge and understanding assessed by management. All new staff were provided with child protection training before starting at the service.

Systems had been introduced to ensure management were aware of any issues and concerns about the children and families in their care. All children's files had been checked after inspection to ensure the service was getting it right for each child. The manager and senior practitioners audited the children's personal plans every month. This helped ensure there was no missed information to support children's individual needs.

Requirement 2

To ensure children receive high quality early learning and childcare, are kept safe and their wellbeing needs are met, the provider and manager must ensure quality assurance processes are introduced and implemented.

Timescale - By 1 April 2019.

This is in order to ensure that care and support is consistent with the Health and Social Care Standards which state 'I benefit from a culture of continuous improvement, with the organisation having robust and transparent quality assurance processes.' (HSCS 4.19) and in order to comply with Regulation 3 (Principals) of the Social Care and Social Work Improvement Scotland (Requirements for Care Services) Regulations 2011.

This is in order to ensure that care and support is consistent with the Health and Social Care Standards which state that, 'As a child, I can direct my own play and activities in the way that I choose, and freely access a wide range of experiences and resources suitable for my age and stage, which stimulate my natural curiosity, learning and creativity.' (HSCS 2.27).

Recommendation 2

To ensure children's health and wellbeing needs are met, the provider and manager should ensure children are offered healthy food choices in line with the best practice guidance, 'Setting the Table.'

This is in order to ensure that care and support is consistent with the Health and Social Care Standards which state that, 'I can choose suitably presented and healthy meals and snacks, including fresh fruit and vegetables, and participate in menu planning.' (HSCS 1.33).

Recommendation 3

To ensure children are comfortable and safe when sleeping, the provider and manager should ensure children are not sleeping for lengthy periods of time in pushchairs.
