About the service

Rainbow Britez Childminding service is provided from the childminder's home in the residential area of Strathaven, South Lanarkshire. The childminder is registered to provide a care service to a maximum of six children at any one time up to 16 years of age.

Children are cared for in the living room area. Children have access to a bathroom, kitchen and rear garden. The service is located close to local parks, amenities and primary schools.

About the inspection

This was an unannounced follow up inspection which took place on 24 November 2025 between 15:00 and 17:00. The inspection was carried out by one inspector from the Care Inspectorate. To prepare for the inspection we reviewed information about this service. This included previous inspection findings, registration information, information submitted by the service and intelligence gathered since the last inspection. In making our evaluations of the service we observed practice and daily life and reviewed documents.

Key messages

The childminder has developed a sleep policy in line with best practice guidance.

The childminder reviewed her practice and made effective changes to keep children safe.

What the service has done to meet any requirements we made at or since the last inspection

Requirements

Requirement 1

By 12 November 2025, the provider must make proper provision to ensure all minded children are not left unattended at any time.

To do this the provider must, at a minimum:

- a) Implement clear supervision protocols during school/nursery drop off and collection times for all children.
- b) Implement clear sleep policy and procedures, including supervision during this time.

This requirement was made on 7 November 2025.

Action taken on previous requirement

The childminder has developed drop off/collection procedures, these include never leaving children unsupervised.

The childminder has developed sleep policy and procedures, these are in line with best practice and include never leaving children unsupervised.

The childminder has reflected on her practice and made significant improvements. She confirmed she would never leave children unsupervised.
