## Job purpose

To provide a confidential, efficient and effective secretarial and administrative support service to the Interim Executive Director of Transformation, ICT and Digital.

#### **Key responsibilities**

- Check and prioritise all email correspondence and meeting invitations.
- Develop and administer a system for dealing with enquiries, recording, acknowledging receipt of and re-directing correspondence, and monitoring progress of responses
- As required, compose responses to routine correspondence for the Interim Executive Director's signature and deal with correspondence in their absence i.e. appropriate redistribution.
- Monitor progress of the preparation of replies by colleagues to correspondence to the Executive Director.
- Manage and co-ordinate the Executive Director's diary, making appointments and arranging meetings, events, booking venues, organising catering and hospitality for visitors as necessary.
- Make all travel and accommodation arrangements for the Executive Director.
- Prepare and circulate agendas and paperwork for meetings as required.
- Attend meetings as required at various locations across Scotland, in order to take notes/minutes and prepare action records
- Assist in the design and preparation of PowerPoint presentations/speeches as required.

- Establish good working relationships in regular communication with other officers of the Care Inspectorate, members of the Board, external partners, Scottish Government and members of the public.
- Carry out your duties in accordance with our Health and Safety policies, procedures, guidance, practices and legislative requirements, taking reasonable care for your safety and that of others who may be affected by what you do or fail to do while at work.

## Relationship management

- Ensure productive and smooth working arrangements and protocols between staff delivering directorate support and all other Care Inspectorate employees.
- Develop and maintain constructive and co-operative working relationships with internal and external stakeholders to ensure effective and efficient directorate support.
- Demonstrate a commitment to the Care Inspectorate's aims, vision and values and to the Care Inspectorate's overall objective of improving care in Scotland.
- To ensure effective communication of the Care Inspectorate's work with people who experience care, carers, relatives and advocates.
