Response

We are seeking to engage with four care homes (two each from two different geographic regions) and provide reminiscence sessions with two care homes on a joint basis. The sessions will be hosted by volunteers from Screen Memories via a video call with the two care homes. Care home staff, carers and/or volunteers in each care home will need to be present to enable greater interaction for the individuals who wish to participate.

The number of people who join in the session will be based on those who express an interest in each care home, with appropriate support to enable participation. We would recommend between 4 and 8 people.

We will run two sessions approximately four weeks apart with the two care homes. The sessions will take place in a morning or an afternoon and will last between 30 minutes and one hour depending on the level of engagement and interaction. We would discuss with the care homes the opportunity to introduce an international element with a possible third session providing interaction with people living in a care home in Canada or America.

Opportunities may exist to participate in further session with people living in their own homes or those receiving support in day care centres.

We are partnering with Memories International and Carnoustie Memories in order to facilitate these events and the Care Inspectorate is supporting the evaluation of the project.
