1.0 INTRODUCTION

This is my sixth Chair's report which highlights a few of my activities since the Board last met in October.

2.0 ANNUAL REPORT AND ACCOUNTS

The Care Inspectorate Annual Report and Accounts have been placed before Parliament in December.

Highlights include the rise in numbers of complaints handled by the Care Inspectorate about services. Press coverage has been generally favourable.

3.0 MINISTERIAL RESHUFFLE

The recent Ministerial changes at the Scottish Government have had an impact on the Care Inspectorate.

The CI reports to the cabinet secretary for Health and Well Being and also their Minister for Health.

Alex Neil has moved from his role as Cabinet Secretary for Health and Wellbeing to become Social Justice Secretary while Michael Mathieson has become Cabinet Secretary for Justice Minister.

The new ministerial team to whom we will now report is Shona Robison, who becomes Cabinet Secretary for Health and Well Being and Maureen Watt who is the new Health Minister.

The Chair and Chief Executive already have a meeting with the new Cabinet Secretary in the diary for January.

4.0 VISIT TO RQIA

Together with the Chief Executive I visited our colleagues in Northern Ireland in November to discuss issues or common interest and to learn from each other experience.

Northern Ireland has long had integrated Health and Social Care so it was an opportunity to hear how integration had been progressing over the years since it was introduced, and to discuss our approach utilising complaints about services to help inform inspection and improvement activities.

The exchange of views and experiences was very useful and I am most grateful to the RQIA for their hospitality.

6.0 HIS MINISTERIAL REVIEW

The annual review of Healthcare Improvement Scotland took place in November shortly after the Scottish Government reshuffle.

It was the first such event for the new Health Minister Maureen Watt who gave HIS a thorough examination. The Care Inspectorate was also involved in the discussions with the minister posing questions about Joint Strategic Inspection.
