## Main findings

- The total number of registered childcare services<sup>1</sup> decreased by 0.6% from 10,159 in 2011 to 10,099 in 2012. This decrease of 60 services is the result of a net change of 85 cancelled daycare services offset by an increase of 25 childminding services.
- The rise in the number of childminding services from 6,249 in 2011 to 6,274 in 2012 was mirrored by a rise in attendance; around 30,390 children (3.3% of the population aged 0-15 years old) attended a registered childminding service in November 2012 compared to 29,150 (3.2% of the population aged 0-15 years old) in November 2011.
- The number of daycare of children services fell from 3,910 in 2011 to 3,825 in 2012. This was reflected in the number of children attending daycare services in November 2012 which was less than the previous year 191,270 children (20.9% of population aged 0-15years old) attended in 2012 compared to 193,210 (21.2% of population aged 0-15 years old) in 2011. Over the same period the child population in Scotland increased by 1,354 from 913,317 to 914,671.
- Overall, around 221,660 children (24.2% of population aged 0-15 years old) attended registered services in the last full week before 30 November 2012, a decrease from the 222,360 (24.3% of population aged 0-15 years old) attending in the previous year.
- The largest proportion of daycare of children services (excluding childminders) are operated by local authorities (45.1%). This percentage has been increasing slightly from 44.6% since 2009. In 2012 28.3% of child care services were private compared to 28.6% last year and the proportion of not-for-profit services decreased slightly from 10.8% to 10.6%.
- The number of childcare services varied across urban and rural areas. In general there were more services per 10,000 head of population in rural areas (149.3 services in remote small towns) compared to urban areas which had fewer services per head of population (83 services in large urban areas), but services in urban areas were larger in terms of children attending (26 children on average per service) compared to 14 children on average in rural areas. In other words there were more services with fewer children in rural areas but fewer services with more children attending in urban areas.
- Children/family centres, crèches and holiday play schemes appear to be 'urban' services; very few rural areas have such service types.
- In large urban areas children/family centres have an average capacity of 56 children, which is higher than all other service types.

<sup>&</sup>lt;sup>1</sup> Childcare services includes childminding services and daycare of children services such as nurseries, playgroups, out of school clubs and holiday play schemes.

- There were over twice the number of childminding services per head of population in remote small towns compared to large urban areas (95.5 to 43.2). However, the size of childminding services was similar across urban and rural areas with around six places per service, an increase from five the previous year.
- There were half as many childminding services per head of population in the most deprived areas (54.4) compared to the least deprived areas (107.3). Daycare services were more evenly spread across the least deprived and most deprived areas.
- The extent of pre-school education provision is very similar to the previous three years. Overall, 92% of all nurseries were providing pre-school education through either local authority or partnership funded education. Local authority/partnership funded education was provided in 68% of all children/family centres and 66% of playgroups.



## Background and methodology

- The Care Inspectorate regulates care services for children and adults in Scotland. This includes a wide range of services for children and young people, such as fostering, adoption and residential care. This publication focuses on childminding and daycare of children services. Statistics on, for example, looked after children are published by the Scottish Government and can be found at:

- This paper reports on the provision and use of daycare of children and childminding services registered with the Care Inspectorate as at 31 December 2012. Each daycare of children service can provide a range of different types of provision, for example a nursery can also provide a breakfast club and an out of school club. In this report we have only used the main type of provision so a service that provides a nursery as main provision but also provides out of school club, will only be recorded as a nursery. This may lead to under-reporting of the availability of some types of provision.
- Previous versions of this report which were published to cover the years 2010 and 2011 are available at www.careinspectorate.com under 'Professionals' and selecting 'Statistics'.
- The statistics in this report are produced using information from the latest Care Inspectorate annual returns which asked for information about the previous calendar year (1 January 2012 to 31 December 2012) and the Care Inspectorate service list (as at 31 December 2012). Figures relating to previous years are taken from the Childcare Statistics 2010 and 2011 publications.
- Our inspectors use the annual returns when planning care service inspections and carrying out risk assessments. Some of the information in the returns is also aggregated and used by the Care Inspectorate to inform wider statistical analysis and comparisons across, for example, care service providers and geographical areas.
- The Care Inspectorate requires (under the Public Services Reform (Scotland) Act 2010, section 53(6)) all providers that are registered with the Care
  Inspectorate to complete and submit an annual return in order to provide the Care Inspectorate with the information needed to help plan and carry out
  inspections effectively. Although services registered after 1 October 2012 do not have to submit an annual return for December 2012, we encourage
  them to do so.
- Of the 10,099 childcare services registered with the Care Inspectorate as at 31 December 2012, 9,017 (90%) submitted an annual return, a 2% increase compared to the previous year. The annual return data has been weighted to deal with non-response and so there will be an element of uncertainty in the final results. For this reason some of the tables contain figures which have been rounded to the nearest 10, therefore rounded figures may differ slightly to the overall totals.

Please note that where a table contains percentages, those that are based on numbers equal to or smaller than 10 are shown in orange.

Further information on the data sources used in this report, as well as detailed response rates and an explanation of the applied weighting can be found in the technical appendix.

#### How these statistics are used:

The main use of childcare statistics is for monitoring the overall system of childcare provision and use, as well as individual policies, some of which are discussed below.

- The Scottish Government's Early Years Framework (2009) states a commitment to giving children the best possible start in life, aiming to break negative cycles of inequality through early intervention. As part of the government's early intervention agenda, Getting it Right for Every Child (GIRFEC) provides guidance on a consistent and integrated approach to support children across Scotland, translated through the SHANARRI framework of wellbeing indicators: Safe; Healthy; Achieving; Nurtured; Active; Respected; Responsible; Included. The figures presented in this report on the availability of childcare services by level of deprivation of an area, as well as statistics on the number of services providing pre-school education, philosophies adopted by service providers, and the provision of meals and snacks across different types of daycare services, provides a valuable insight into childcare in Scotland for those that also have an interest in the Early Years Framework. These figures are also further evidence for those with an interest in the Early Years Collaborative. The Early Years Collaborative is the coalition of community planning partners including social work and social care services, health, education, police and the third sector. It has been established with an objective to "accelerate the conversion of the high level principles set out in GIRFEC and the Early Years Framework into practical action".
- The Scottish Government's Children and Young People (Scotland) Bill was introduced to Parliament on 17 April 2013. It aims to ensure all of the Scottish Government's policies and legislation take account of and promote the rights of children and young people for "Scotland to be the best place to grow up in by putting children and young people at the heart of planning and services and ensuring their rights are respected across the public sector". As well as placing emphasis on key aspects of GIRFEC, the Bill includes proposals to increase the amount and flexibility of free early learning and childcare. Specifically, the legislation will extend the statutory childcare entitlement for looked after 2-4 year olds. The figures presented in appendix tables 5 to 10 provide a measure for monitoring usage of childcare services.
- Other key policy documents, for which this report may provide interesting statistics to monitor performance and progress, include:
  - Early Years Framework: Progress So Far (2011)
  - Guide to Getting it Right for Every Child (2012)
  - National Parenting Strategy: Making a positive difference to children and young people through parenting (2012)
  - Play Strategy for Scotland: Our Vision (2013)
- Information in this report can be used to monitor long-term trends, however care should be taken when interpreting year on year changes in disaggregated data such as counts of daycare services broken down by type and location. The nature of the main administrative data source used to compile these statistics is such that recording practices of providers can differ from one year to the next, causing fluctuations in smaller numbers that may be representative of the way in which service providers complete their annual return as opposed to real changes in the childcare sector. The annual return figures should be treated as estimates and not exact values.

- In June 2013 the Care Inspectorate asked staff, stakeholders and users of the Childcare Statistics 2011 for feedback on the report. The aim is to make the publication as useful as possible. A recommendation we incorporated into the new report is to include more historic data in charts and tables. We have included historic trends where appropriate given the points in the previous bullet point.
- Definitions of the terms used throughout this publication can be found in the **technical appendix**.
- Counts published in this report of the number of childminding and daycare services as at December 2012 are also published by the Scottish Social Services Council (SSSC) in their Scottish Social Services Sector: Report on 2012 Workforce Data. The figures may vary slightly due to differences in the way the Care Inspectorate and SSSC classify an active service. See the **technical appendix** for more information.



### Number of registered childcare services in Scotland

At 31 December 2012 there were 10,099 childcare services<sup>2</sup>, of which 6,274 were childminding services and 3,825 were daycare of children services.


Table A and Figure A (below) show that the total number of registered childcare services in Scotland decreased by 0.6% between 2011-2012. This net decrease is the result of a decrease of 85 daycare services and an increase of 25 childminding services.

On 1 April 2012, childminders became responsible for paying for their own Disclosure Scotland checks, as well as those of other people over 16 years old resident in their household, but this does not appear to have affected new registrations significantly. New childminding registrations fell from 726 in 2011 to 710 in 2012, but there were only 685 cancellations, resulting in an overall increase of 25 childminders.

#### Figure A: Total number of registered childcare services, as at December 2008, 2009, 2010, 2011 and 2012


A daycare service can operate more than one type of provision. Therefore, please note that under-reporting of some service types may result from the analysis of a service's main type of service only. For example a service which provides a nursery as main provision but also provides a breakfast club, will only be recorded as a nursery.

**Figure A** (above) demonstrates that, apart from a small increase in 2011, the total number of childcare services has continued to fall from December 2008 to December 2012. It shows that childminding services have grown every year since 2008. In contrast the total number of daycare of children services has continued to fall from 4,211 in 2008 to 3,825 in 2012. A decrease of 85 services was observed over the past year, 3,910 to 3,825 services.

Figure B (below) presents a breakdown of these daycare services. The chart shows that playgroups and out of school clubs account for over three quarters of the decrease in the total daycare of children services between December 2011 to December 2012.

The chart shows that there has been a decrease over the past year in the number of daycare services across all main types of daycare, except for nurseries which remained the same.

The types of services noted above (out of school clubs, playgroups and so on) are based on the main type of provision recorded by a service. Some of these services may provide additional services. For example, a service where the main provision is a nursery may also provide an out of school club.

**Table B** demonstrates that two thirds of children/family centres also provided an additional type of daycare service in 2012 as was the case in 2011. Furthermore all services categorised as 'other' provided more than one type of service. Services where the main type of care was a crèche, holiday play scheme, nursery or playgroup were less likely to provide an additional service.

The most common additional type of daycare in 2012 were breakfast club services: 536 services recorded having a breakfast club in addition to their main type of daycare. Of these 536 services 94% were nurseries and out of school clubs (51% and 42% respectively). Although there were only 53 registered services where the main type of daycare was holiday play scheme (see **table B** above), **table C** (below) shows that 532 services operated a holiday play scheme in addition to their main type of daycare. Of these 532 services, 67% provided out of school clubs as their main type of daycare. Holiday play schemes were less likely to be the main type of daycare and the second most common additional service type after breakfast clubs.

**Table D** (below) shows that 9,550 (95%) of all registered childcare services were active (actively providing a service as at 31st December 2012). There were 549 inactive services on the register. Most of the inactive services (524) were childminding services.


## Number of children using registered childcare services in Scotland

The rise in the number of childminding services (See **table D** above) between 2011 and 2012 was mirrored by a rise in attendance. Around 30,390 (3.3% of the population aged 0-15 years old) attended a registered childminding service in November 2012 compared to 29,150 (3.2%) in November 2011). The decrease in number of daycare services is mirrored by the drop in the number of attendances from 193,210 to 191,270<sup>3</sup> between 2011 and 2012. Although the number of services has decreased, changes in the child population mean that the percentage of the age-specific population<sup>4</sup> attending services has not changed much from the previous year.

**Figure C** (below) shows that as at 31 December 2012 the highest proportion of daycare of children services (excluding childminding) were run by local authorities (45.3%). This sector has been rising steadily since December 2008. This is in contrast to both the private (28%) and not-for-profit (27%) management sectors which both decreased between 2011 and 2012. The private sector had been increasing every year since 2008 before dipping in 2012. The

not-for-profit management sector has been steadily declining since December 2008 (see appendix table 2a).

<sup>3</sup> Note – it is not appropriate to compare the number of children attending daycare services disaggregated by the main type of daycare over time because variation in the way service providers record information from one year to the next can lead to large misleading fluctuations in the number of children attending services. Also, year to year fluctuations in both the population and the number of services will affect the numbers attending/registered from one year to the next. Change over time in the number of children using childcare services are shown at an aggregate level in Table E.

<sup>4</sup> Age-specific population is the population of children that fall within the age group that would use a particular service. The percentage of the age-specific population is then calculated by using the age-specific population denominator. For example, for out of school clubs the denominator is population of children aged 4-15 years old.


# Number of registered childcare services in local authority areas, urban and rural areas and by deprivation

As **figure D** shows there was variation in the numbers of active childcare services per 10,000 population aged 0-15 years old by local authority area. There was also variation in the average number of children attending each service. For example, the number of services that were actively providing a service ranged from 58.5 per 10,000 population in Glasgow City to 187.5 per 10,000 population in Orkney Islands. In Glasgow City the average attendance was 41.3 children per service, whereas in Orkney the average attendance was 10.9 children per service. In other words, there were more services in rural authorities in 2012 with less children attending each service compared to urban authorities where there were less services and more children attending.

There was variation in the numbers of childcare services per 10,000 population aged 0-15 years old by urban and rural area and by level of deprivation (see **appendix table 4a**). In general there was a greater number of services in remote areas compared to urban areas. For example there were more nursery services per head of population in remote rural areas (52.6) compared to large urban areas where there were under half the number of nursery services per head of population (23.8). There were more childminding services per head of population in remote small towns (66.1) compared to large urban areas (43.2).

The rate of childminding services, nurseries, out of school clubs and playgroups per 10,000 population was higher in the least deprived areas compared to the most deprived areas.

## Number of children using registered childcare services in Scotland

In this report, we present information about children registered with a childcare service as at 31 December and children who attended over a specific week.

In the last full week of November 2012, 221,660 children (24.2% of population aged 0-15 years old) attended registered services in Scotland, a slight decrease from the 222,360 (24.3% of population aged 0-15 years old) attending in that week the previous year (see table E).


Around 240,900 children (26.3% of the population aged 0-15 years old) were registered with a childcare service as at 31 December 2012 (see **appendix table** 6). Therefore the gap between the number of children using a service and the number registered with a service in Scotland is narrowing.

For most service types the total number of children using the service in November 2012 was between 85-100% of the number registered to use the service in December 2012.

This was not observed in all service types however, with the exceptions being crèche and holiday play scheme service types. The biggest difference was observed in crèche services where the number of users was almost half the number of registered users (3,710 users and 7,050 registered users). In 2011 it was calculated that there were four times the number of registered users compared to actual users in crèche services. This trend was also observed for holiday play schemes. This is reflective of the way in which these services define and count 'registered' children compared to other service types. However, since this gap seems to be decreasing, this may reflect better recording practices<sup>5</sup>. **Figure E** (on the next page) demonstrates this trend further.

<sup>&</sup>lt;sup>5</sup> Crèche service information on registered users and children attending was separated for the first time in 2012. This may have helped the service provider record numbers between nurseries and crèche services more accurately. Furthermore, the annual return was changed to record children registered and attending a service by individual years up to the age of 7. This may have made recording more straightforward than previous years.

In November 2012 an average<sup>6</sup> of 23 children attended an active registered care service in Scotland. The average attendance varied between management sector (local authority, private and not-for-profit) and service type (see **appendix table 10**). For example, average attendance was higher in privately run nurseries (67.3 children per nursery) compared to local authority run nurseries (47.9 children per nursery) and those run on a not-for-profit basis (47.5 children per nursery). The average attendance of holiday play schemes also shows considerable differences in relation to management sector. A private holiday play scheme had an average of 118 children attending in the last full week in November, whereas the averages were much lower for not-for-profit and local authority management sectors, at 46 and 12 children attending respectively.

Although the number of children attending daycare services has decreased the average number of children attending per service has increased by approximately 6 children per service; from 49.9 in 2011 to 55.7 in 2012.

Around 2,270 children attended a holiday play scheme in November 2012. This low value is understood to be a reflection of the holiday season in which these schemes normally operate and it is thought not many operate in the last full week in November. A small number of holiday play schemes (weekend play schemes) operate outwith school holidays. A future recommendation would be that we ask holiday play schemes to provide information for a more reflective month of service usage.

 $<sup>^{6}</sup>$  Average attendance is calculated as the total children attending in a week divided by the number of services registered. Children may be counted twice if they attend more than one service.

# Number of children using registered childcare services in urban and rural areas and by deprivation

The number of children attending each childcare service varied between urban and rural areas and by level of deprivation. In terms of numbers of children attending, services in urban areas were larger, although there were less of them per head of population, while services in remote areas were smaller, but there were more of them per head of population.

In urban areas 65 children on average were attending each nursery service compared to 18 children per nursery service in remote rural areas. However holiday play schemes demonstrated the highest average number of children per service in November 2012 in remote town areas. There were on average 120 children attending each of these services, compared to 50 children on average in urban areas. This average was even lower in rural areas with between 0-12 children on average attending holiday play schemes in these areas in November 2012. The holiday play scheme services with the highest number of users were run in the voluntary or not-for-profit sector. This is expected as over half of holiday play schemes (58%) are voluntary or not-for-profit.

On average there were 5.3 children attending childminding services in Scotland. This ranged from 4.8 children per service in urban areas to 6.0 children in rural areas. In the most deprived area of Scotland there were fewer childminding services per 10,000 head of population (20.4) compared to the least deprived area (70.9).

The average number of children attending crèche services in the most deprived area was almost half of those attending crèches in the least deprived area.

## Service provision

#### Pre-school education as at 31 December 2012

The proportion of services providing pre-school education remains similar to previous years.

**Table F** (below) shows the distribution of pre-school education provision across management sector (local authority, private, and not-for-profit) as at December 2012. The table demonstrates that 57% of pre-school education was delivered by local authority run services in 2012; down from 59% in 2011. 22% were delivered by privately run services and 13% by services run on a not-for-profit basis. However this distribution varied depending on the services' main type of provision. For example services with playgroup as main type of provision; 89% was voluntary/not-for-profit, 11% was private and 0% local authority provision.

**Appendix table 12** shows that 68% children/family centres, 92% of nursery and 66% playgroups were providing pre-school education. For nurseries and children and family centres these are the same proportions as calculated in December 2011. For playgroups there was a 3% drop. #### Languages and service philosophies as at 31 December 2012

The trends in language and service philosophies used in December 2012 remains very similar to that recorded in December 2011. Around 99% of active childcare services (excluding childminding services) used the English language in delivering the service.

- Around 4% of services used another language (other than Gaelic or sign) as well as English.
- Around 2% used sign language as well as English.
- Around 2% of all active services (67 services) used Gaelic in their service. Twenty seven of these delivered their service purely in Gaelic (no English used). This is a decrease from 40 services in 2011 and these all operated in the Highlands and Islands with the exception of one service in Glasgow City.

Excluding childminding services, around 1% (33) childcare services used a Suzuki/Montessori philosophy. Nursery and crèche service types were the biggest users of this philosophy. Around 0.5% (18) services used a Steiner philosophy. The majority of the services that used a Suzuki/Montessori service philosophy were run on a private or not-for-profit basis.

#### School term/holiday availability as at December 2012 (appendix table 15)

The majority of childminding services provided a day-time only service during term time. Only 2% provided an overnight service, a decrease from 9% in 2011 during term time with no change of 2% during the holiday period. Holiday play schemes were naturally more likely than other services to be available during weekends, school holidays and after school.

In 2012, 60% of services provided breakfast or pre-school availability during term. This figure is almost halved when childminding services are excluded from analysis.

#### Sessions available and whether drop-in or planned as at 31 December 2012 (appendix table 16)

Excluding childminding services, nearly half (47%) of childcare services provided either whole day sessions, or a mixture of whole-day and part-day sessions. Playgroups and crèches were most likely to only provide part-day sessions, with nearly all playgroups (94%) only operating this type of service. Holiday play schemes were the most likely service type to provide whole day sessions, with nearly half of these services providing whole-day care. All other service types only had between 0-7% of child care services operating whole-day sessions.

Excluding childminding services, nearly all (99%) of childcare services were available on a planned rather than a drop-in basis. The exceptions were crèche services (where nearly a third of services offered drop-in service) and 1% of out of school clubs.

#### Meals and snacks as at 31 December 2012 (appendix table 17)

Around 97% of daycare services (excluding childminding services) provided snacks (either provided by the service or by parents) and almost a quarter (23%) provided meals (either by the service and prepared internally or externally or by parents).

Of nurseries, 70% (1,684) did not provide meals in the service and 3% did not provide any snacks. Around 75% of the 1,684 nurseries operate on a part-day basis only, which may explain the absence of meal provision.

The provision of meals varied between service types. Half of holiday play schemes did not provide any meals and the other half provided meals by the parent (44%) or by the service (6%).

Of crèche services, 88% did not provide any meals in their service. This type of service is often mobile which would make it difficult to provide meals. However, 61% of crèche services did provide snacks and a further 11% recorded that snacks were provided by parents.

Less than 1% of playgroups did not provide any snacks. Of playgroup services which provided snacks, 96.2% had snacks provided by the service alone. Around 84% of childminding services in 2012 provided meals to children attending the service, prepared either by the service or by parents. This is a decrease from 93% providing meals in 2011. The number of childminding services providing 'service only' meals increased between 2011 and 2012 from 29% in 2011 to 31% in 2012.

Of childminding services, 93% provided snacks in 2012 - a decrease of 3% from 2011.

It should be noted that in 2010 the Food Standards Agency issued guidance requiring all new childminders to register with the local authority as a food business if they provided more than water.




Figure 1: Age profile of active childminders, as at 31 December 2012 (based on 5,458 active childminders with a known age)

# **Technical appendix**

# Definitions of the terms we use

**Childminding** is defined by the Public Services Reform (Scotland) Act 2010 as:

"Looking after one or more children on domestic premises for reward for a period of more than two hours in any day. However this does not include:

- Where children are closely related to the carer
- The fostering of children
- Caring for children in their own home.

"By law, all childminding services must be registered with the Care Inspectorate.

"Childminding services may operate in several ways:

- An individual may operate a childminding service alone.
- A partnership of two or more people may operate a single registered childminding service.
- Childminding services that are separately registered may work together in the home of one of the registered childminding providers.
- No matter which of the operating methods is used, a provider of a childminding service may have paid or unpaid assistants to help provide the childminding service."

Daycare of children is defined by the Public Services Reform (Scotland) Act 2010 as:

"A service which provides care for children on non-domestic premises for a total of more than two hours per day and on at least six days per year. Includes nursery classes, crèches, after school clubs and play groups and can be run on a public, private or voluntary basis.

"The definition does not include services which are part of school activities. Nor does it include activities where care is not provided such as sports clubs or uniformed activities such as Scouts or Guides."

For the purposes of this statistical report, each of the registered daycare of children services has been assigned to one of the following categories of main service provision. This main service type is based on information supplied in annual returns. If a service did not respond to an annual return in a given year, then their main type of service has been estimated by using annual return information submitted in another year, or from other information about the service, for example their conditions of registration.

Main Service type	Description
Children/family centre	Provides a similar service to a community nursery or nursery centre. Provides daycare and education together with a range of support services for families
Crèche	Provides drop-in care for children in order to enable adults to engage in activities such as further education, shopping or attending a meeting
Holiday play scheme	Provides a service which allows school age children to take part in a broad range of supervised leisure and educational activities during the school holidays (this does not include activity-based clubs)
Nursery	Provides daycare facilities for children aged 5 years or under. The service is normally used by parents/carers on a regular basis rather than a drop-in basis and the service is provided as a minimum during the school term
Nursery providing additional childcare such as a breakfast club or an out of school club	As above but where additional childcare (for example, breakfast club or out of school club) is recorded as being provided
Out of school club	Provides care for school age children in the absence of parents or carers from the end of the school day until parents can collect their children, and also before school starts
Out of school club providing additional childcare, such as a breakfast club or holiday play scheme	As above but where additional childcare (for example, breakfast club or holiday play scheme) is recorded as being provided
Playgroup	May also provide pre-school education in partnership with the local authority. Will usually rely heavily on parents or carers who volunteer their services, although may also employ paid staff for example a play-leader or assistant
Other services	Includes housing support related services, for example womens' aid centres, and also services that cannot easily be assigned to one of the other categories (for example services providing for additional needs up to age 16 on a respite basis)

# Data sources

Care Inspectorate service list (as at 31 December 2012) has been used to provide figures on:

- the total number of registered 'Daycare of Children' and 'Childminder' services
- whether services were active or inactive
- whether services were run by local authority, private or not-for-profit
- the registered capacity of each service (that is the total number of children that can be cared for at any one time)
- the postcode of the service, from which we have derived the local authority, deprivation category and urban-rural category of the service.

Care Inspectorate annual returns (as at 31 December 2012) have been used to provide estimates for:

- the main service type, for example nursery, playgroup, out of school club and so on
- the number of children using the service in the last full week before 30 November
- the number of children registered with the service as at 31 December 2012
- the age groups catered for and term-time/holiday-time availability of the service
- whether the service was available drop-in or planned and whole-day or part-day
- whether the service provided pre-school education as part of local authority or partnership provision
- whether meals or snacks were provided by the service or by the parents
- the languages and service philosophies used by services
- characteristics of childminding services.

# Data cleaning and dealing with missing data

Where there have been any data-input errors or incomplete responses identified in relation to specific questions, these have been fixed where possible before any analysis has taken place. For example, where a service's status was 'active' as at 31 December 2012 but the service reported working zero hours and recorded zero number of users the status was changed to 'inactive' before any analysis has taken place (for this reason the count of active childminding services published in this report differs from that published by the Scottish Social Services Council in their Workforce Data report).

Not all childcare services have submitted an annual return. This means that there are some gaps in the data which we need to take account of.

For dealing with missing data, the following approach has been taken:

# A. Identification of under-representation in annual return responses:

Within the responses of annual returns, it may be possible that some types of services are less likely to respond than other types of services. If this isn't adjusted then the final results would likely to be biased towards the characteristics of services that had responded and therefore not representative of the entire set of registered services.

Logistic regression\* has been used to help establish specific characteristics of services that appeared to be significant factors in terms of the likelihood of nonresponse to an annual return. Over and above the main service type being a factor in response rates, the other factors for December 2012 annual returns are summarised below (factors for previous years of annual return data are similar and further details are available on request):

**Note:** These are factors **in addition** to the main service type factor (which is also a significant factor in determining likelihood of a response). \*Logistic regression is a type of statistical analysis used for predicting the outcome of a categorical variable based on one or more other variables.

# B. Weighting and grossing-up data to obtain overall estimates:

Weights were calculated for the significant factors associated with non-response. This is so we could adjust for the types of services that we knew were under represented by a certain level in the annual return responses. We then applied the weights to each type of service in grossing-up\* the annual return data rather than simply grossing-up evenly across all services. This has produced final estimates which should be more representative of the overall mix of different types of registered services.

\*Grossing-up is the process of multiplying values (such as the number of children attending a service, or the number of childminders with a qualification) equally by a factor between 1.0 and 1.9 to account for services that did not submit an annual return. Weighted grossing-up is the process of multiplying values by a factor that varies depending on the combined characteristics of the service to which the value belongs.

# C. Testing the impact of using weighted data:

To help assess the impact of applying weights to the annual return data, some of the final results have been compared to estimates obtained from simply grossing up without weights (that is ignoring any potential under-representation).

For the number of children attending a childminding service at end of November 2012, the weighted results (as used in the publication tables) produce an estimate of 30,390. This is higher than the non-weighted and non-grossed up figure of 27,145. This difference is as we would expect given that we know that lower-capacity childminding services are on average less likely to complete an annual return. Therefore the non-responses (which we need to gross-up to take account of) are likely to include a greater proportion of the lower-capacity childminding services, and so the use of weights to reflect this will produce an overall estimate which is lower than a simple non-weighted grossing-up would produce.

For childcare services excluding childminding services, the weighted results (as used in the publication tables) produce an estimate of 191,270 children attending services. This is slightly lower than the non-weighted grossed up figure of 187,710. This can be explained largely by differences in the response rates per main type of service. In particular, holiday play schemes and crèche services have lower response rates compared to nurseries. Because holiday play schemes and crèche services also have lower attendances per service on average when compared to nurseries, this means the weighted result is likely be lower given that we are grossing up a greater proportion of lower-attendance services within the set of non-responding services.
