## **NOTE FOR ALL CHILDCARE PROVIDERS**

To all registered childcare providers,

We are nearing the end of 2020 and it's been a challenging year. I want to thank you for all your efforts this year in continuing to provide nurture, love and care for children and families in Scotland in the toughest of circumstances. While we were all disappointed that the expansion to 1140 hours couldn't go ahead as planned in August 2020, Team ELC has made tremendous progress in delivering more expanded entitlement to children and we are now in a position to confirm a new delivery date.

### **Early Learning and Childcare (ELC) Expansion**

As you will be aware, back in March we took the difficult decision to pause the ELC expansion. This decision was necessary to allow Local Authorities and childcare providers to respond to the pandemic and provide critical childcare to key worker families and vulnerable children and because elements of the expansion simply couldn't proceed during lockdown.

Over the past few months we've continued to monitor the progress across Scotland to help Scottish Ministers and COSLA Leaders determine when we could realistically deliver the 1140 hours expansion in full, while ensuring quality of experiences for children remains at the heart of all that we do.

COSLA Leaders and Scottish Ministers have now agreed the recommendation of the ELC Joint Delivery Board that the 1140 hours expansion should be implemented across Scotland in August 2021. Scottish Ministers will bring forward legislation to put this new date in law in early 2021.

Today the Minister for Children and Young People, Maree Todd MSP, and Councillor Stephen McCabe, COSLA Spokesperson for Children and Young People have issued a Joint Statement which you can read [here](#).

We look forward to working with the Scotland-wide Team ELC as we look ahead to 2021, now that we can offer certainty to families on when every child will receive 1140 hours of funded ELC. Collectively we can focus on realising the transformational benefits the expansion will bring including improved educational and development outcomes for children, enhanced family wellbeing and greater employment and training opportunities for parents and carers.

## **Childcare guidance and Infographics**

The First Minister announced a change to the [guidance on the self-isolation](#) period on 11 December. Until now household members and close contacts of people testing positive for coronavirus have been required to self-isolate for 14 days. That same 14 day self-isolation period has been applied to people travelling to Scotland, from countries that are not on the [quarantine exemption list](#). Following consideration of the latest scientific evidence, the UK's four Chief Medical Officers have advised that the self-isolation period can be reduced to 10 days. This change will take effect from today, 14 December.

From today anyone who is told to self-isolate should do so for a period of 10 days, not 14. And if you are someone who is already self-isolating, then from today onwards – you can stop once you reach the ten day point. These changes apply to household members and close contacts of people who have tested positive - whether you are notified by Test and Protect or by the app.
